Location:

The property is located in the market town of Holsworthy in the Torridge district of Devon. The town is located circa 36 miles west of Exeter and is historically associated with the farming community. The town has one of the largest livestock markets in the South West which provides a strong local economy based on the agriculture sector as well as local commerce.

The town itself benefits from a compact town centre with local shops, services and amenities which serve the local population. Other notable occupiers include Waitrose (located directly opposite the property), Coombes Menswear, British Heart Foundation and

Simpkin Edwards amongst a number of other local traders.

The town is also served by a number of regular bus routes with Stagecoach operating a service to Exeter, Bude, Tavistock and Barnstaple.

Description:

An exciting opportunity to acquire this former Council depot enjoying a good sized yard space and a range of light industrial workshops and outbuildings occupying a site extending to approximately 0.22 acres. The property, which has road frontage and is close to the town centre, now offers huge scope and potential for a variety of uses to include residential development, subject to all the necessary consents being obtainable.
